

INSTRUMENT RATING -SINGLE ENGINE PISTON FLIGHT TRAINING PACKAGE

The IR/SEP(A) training course aims to upgrade the student pilot's level of proficiency to the necessary standards for operating Single Engine Piston (SEP) airplanes under Instrument Flight Rules (IFR), while flying Instrument Meteorological Conditions (IMC) with a minimum decision height of no less than 200 feet (60 m).

Entry Requirements:

- ✓ PPL(A) or CPL(A)
- ✓ EASA Medical Certificate Class 1 or 2
- ✓ Night rating (if the IR privileges will be used at night)
- ✓ 50 hrs cross-country flight time as Pilot In Command (PIC) in aeroplanes

IR(A) Theoretical Knowledge Instruction (Ground School)

Distance Learning Course:

The IR(A) theory knowledge instruction course consists of 200 hrs total, most of them self-study. The specified classroom hours will be taught by experienced ground instructors in order for the student to achieve the highest level of theoretical knowledge to pass the, seven subjects, theoretical knowledge examinations.

Program's advancement is assessed by means of a series of Progress Tests (PT's) which are incorporated into the syllabus of the course.

The duration of the Theory Knowledge Instruction Course is approximately 6 months.

The IR(A) Theory knowledge instruction course includes 7 subjects, which are divided in the following scientific areas:

- Air law
- Aircraft general knowledge • Meteorology instrumentation.
- Flight planning and monitoring
- Human performance
- Radio navigation
- Communications

NOTE:

If the applicant is a holder of the ATPL Theory Knowledge Examinations, then the IR(A) Theory Knowledge Instruction course is not required as the material would have been covered already, as long as the IR is completed by not more than 3 years after the last written ATPL Theory examination.

IR(A) Flight Training

The flight course consists of two modules (a) and (b) total of **50 hrs** flight training. (see scenario No:1)

The holder of a CPL(A) or of a Course Completion Certificate for the Basic Instrument Flight Module (a) may do only the module (b) total of **40 hrs** flight training. (see scenario No:2)

for PPL holder (1st Scenario)

The flight course consists of two modules total of **50 hrs** of flight training, which may be taken separately or combined:

- (a) Basic Instrument Flight Module
 - √ 10 hrs SEP(A)
 - 5 hrs SEP (aeroplane)
 - 5 hrs FNPT II
- (b) Procedural Instrument Flight Module
 - √ 40 hrs SEP (A)
 - 10 hrs SEP (aeroplane)
 - 30 hrs FNPT II (SEP)

The duration of this flight training course varies from 4 to 6 weeks.

for CPL holder (2nd Scenario)

The flight course consists of one module total of 40 hrs flight training

Procedural Instrument Flight Module

- √ 40 hrs SEP (A)
 - 10 hrs SEP (aeroplane)
 - 30 hrs FNPT II (SEP)

The duration of this flight training course varies from 4 to 6 weeks.

Skill Test:

The duration for the IR/SEP skill test should be at least 1 hr.
